

GENERAL DATA PROTECTION REGULATION for the attention of clients, suppliers and visitors

Revaia respects your privacy and is committed to protecting your personal data in accordance with the General Data Protection Regulation (GDPR) and the Data Protection Act (“Loi informatique et Libertés”). This privacy notice describes how Revaia collects, uses, and protects personal data related to its clients, suppliers, and any other stakeholders.

A. Nature of collected personal data

As a Revaia client, supplier, or visitor to its website/offices, Revaia may collect information about you such as:

- For website visitors: name, email, phone number
- For suppliers: name, surname, job title, email, phone number
- For clients: name, surname, job title, email, phone number, date of birth, KYC documents

Revaia collects this information in order to (i) respond to any information requests from you and other contractual relationships and (ii) comply with its regulatory and legal obligations.

B. Personal data collecting period

Revaia collects your personal data through its website, visits to its offices, meetings/events between you and the Revaia team, and publicly available information.

More specifically:

- For website visitors, the data are collected when you subscribe to our newsletter or when you contact us via our Contact Page for more information.
- For suppliers, the data are collected during the contracting process with subcontractors.
- For clients, the data are collected during office meetings, firm events, or conferences

C. Personal data use

Collected data will help Revaia:

- Maintain a contact directory
- Share relevant marketing information with you (such as business and economic insights)
- Comply with regulatory and legal obligations (such as conflict checks, anti-money laundering checks)
- Understand the use and performance of its website
- For website visitors: gather information (newsletter subscriptions or requests for information)
- For suppliers: manage the subcontracting commercial relationship
- For clients: meet regulatory requirements related to LP commitments

Revaia may share information with its subcontractors. In this case, Revaia will make sure that its partners and subcontractors commit to the GDPR requirements.

D. Personal data retention period

Revaia will only retain your personal data for the longer of (i) the period necessary to fulfill the purpose for which they were collected or (ii) the period required by the CNIL (French Data Protection Authority). Once the period has expired, Revaia undertakes to securely destroy your data, whether in paper or electronic format.

E. Personal data protection

On a daily basis, Revaia has put in place appropriate measures (both technical and organizational) to protect your personal data against unlawful or accidental destruction, accidental loss or alteration, and unauthorized access or disclosure.

F. Personal data transfer

Revaia does not transfer your personal data to countries outside the European Union.

G. Your rights

In line with GDPR and the Data Protection Act (“Loi informatique et Libertés”) requirements, you have the right, at any time, to access, correct, request erasure, object to the processing and request the transfer of your personal data.
